
WHEREAS, the Community and Council recognizes her for her tireless efforts and dedication in promoting the Christmas spirit with her charge in decorating throughout the Village; and


WHEREAS, the Community and Council recognize her service as an active member of the Village of Peninsula Garden Club; and



This Resolution shall take effect on December 10, 2012.






