AN EMERGENCY RESOLUTION CONFIRMING THE APPOINTMENT OF DAVID MOREHOUSE AS A SEASONAL SERVICE DEPARTMENT EMPLOYEE FOR THE LATE SPRING, SUMMER, AND EARLY FALL OF 2016

WHEREAS, the Village has a need for a seasonal Service Department employee for the late spring, summer, and early fall of 2016; and

WHEREAS, David Morehouse has worked as a seasonal employee for the Service Department and has the skills and experience necessary for the position; and

WHEREAS, Council desires to confirm the appointment of David Morehouse as a seasonal Service Department employee for the late spring, summer, and early fall of 2016.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Peninsula, Summit County, Ohio, to wit:

SECTION 1. Council hereby and herein confirms the appointment of David Morehouse as a temporary, seasonal Service Department employee. Mr. Morehouse's work hours and schedule shall be as determined the Mayor. The term of this appointment shall be from May 1, 2016 until October 31, 2016. Mr. Morehouse shall be paid at the rate established for Seasonal Service Department employees in the most recent Village Pay Ordinance.

SECTION 2. All formal actions of this Council concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council, and all deliberations of this Council or any of its committees that resulted in such formal action were taken in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.



This Resolution is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety, and welfare of the residents of the Village of Peninsula for the reason that it is necessary to permit the employee to commence work by the desired start date and will assist with the operation of a Municipal department, and therefore, this Resolution shall take immediate effect upon its passage.

SECTION 4. Effective Date. This Resolution shall take effect on the 9 day of May, 2016.


