**A RESOLUTION AUTHORIZING THE MAYOR TO ACCEPT THE PROPOSAL FROM VANCE'S LAW ENFORCEMENT FOR THE PURCHASE OF AMMUNITION FOR THE VILLAGE POLICE DEPARTMENT AND DECLARING AN EMERGENCY.**

**WHEREAS**, the Chief of Police has requested authorization to purchase AMMUNITION FOR THE POLICE DEPARTMENT FROM Vance's Law Enforcement for the Village Police Department..

**WHEREAS**, this request is not for additional ammunition, but to maintain the stock level within the police department..

**NOW THEREFORE BE IT ORDAINED** by the Council of the Village of Peninsula, Summit County, Ohio

**SECTION 1.** The Village Council hereby authorizes the Mayor to accept the proposal and detail for the purchase of ammunition from VANCE'S LAW ENFORCEMENT as referenced by the attached EXHIBIT A

**SECTION 2.** that this Council hereby finds and determines that all formal actions relative to the adoption of this Ordinance were taken in an open meeting of this Council and that all deliberation of this Council which resulted in formal action were taken in meeting open to the public; in full compliance with the applicable legal requirements including Section 121.22 of the Ohio Revised Code.

**SECTION 3.** That this resolution is hereby declared to be an emergency measure necessary for the immediate conformity with Ohio Revised Code Section 4511.204 and preservation of the public peace, health, safety of the Village residents and shall therefore take effect and be in force from and immediately after its passage.




