The Mayor announced that the next item on the agenda was to discuss the vote to remove the camera from the Council Room. Ms. Holody asked if Council should move to Executive Session to discuss considering pending Sheriff's investigation, pending potential charges. Solicitor Bryan stated that if Council wished to move into Executive Session it would be appropriate under Revised Code Section 121.2223 for the purpose of discussing threatening imminent court action involving the Village. There was a threat of imminent court action. It would be appropriate to move forward to discuss the circumstances.

Mr. Kaplan asked to speak. Mr. Kaplan stated that he is representing Mr. Matusz. He stated that he believed that the section has to do when the Village is threatened. The Solicitor stated that there was a threat against the Village. Solicitor Bryan stated that he and Mr. Kaplan had a conversation, in which Mr. Kaplan raised the possibility of bringing legal action on behalf of Mr. Matusz. Mr. Kaplan stated that if any person is charged with a criminal offense and it turns out that the charges were falsely brought, that there are potential penalties. He stated that he did not threat and is not threatening now. Solicitor Bryan respectfully disagreed.

The Solicitor asked Council if they had any further comments.


