**AN EMERGENCY RESOLUTION AUTHORIZING HOLIDAY BONUSES FOR CERTAIN CATEGORIES OF FULL-TIME, PART-TIME, AND AUXILIARY EMPLOYEES**

WHEREAS, the Village has authorized the establishment of a discretionary Holiday Bonus Program for full-time, part-time, and auxiliary employees on a year to year basis; and

WHEREAS, Council desires to issue holiday bonuses for 2017 as set forth herein.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Peninsula, Summit County, Ohio, to wit:

SECTION 1. A holiday bonus will be paid in December of 2017 to employees of the Village ~~that have worked a minimum of 400 hours~~ in 2017. Full-time employees shall receive \$125.00, and part-time and auxiliary employees shall receive \$65.00.



All formal actions of this Council concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council, and all deliberations of this Council or any of its committees that resulted in such formal action were taken in meetings open to the public and/or in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3. This Resolution is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety, and welfare of the residents of the Village of Peninsula for the reason that Council desires that the bonuses be paid to the employees in December of 2017, and therefore, this Resolution shall take immediate effect upon its passage.


SECTION 5. Effective Date. This Resolution shall take effect on the 15 day of December, 2017.




