WHEREAS, Sections 149.43(E)(1) and 109.43(B) of the Ohio Revised Code require all elected public officials or their designees to attend a public records training seminar approved by the Attorney General's Office; and

WHEREAS, Councilperson Christopher Weigand attended an approved training seminar in 2018; and

WHEREAS, Council desires to designate Mr. Weigand as Mayor Mayer, Mr. Schneider, Ms. Holody, Mr. Kaplan, Ms. Booth, and Mr. Matusz's public records training seminar attendee designee for 2018 pursuant to R.C. 149.43(E)(1).

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Peninsula, Summit County, Ohio, to wit:

SECTION 1. Council hereby and herein designates Mr. Weigand as Mayor Mayer, Mr. Schneider, Ms. Holody, Mr. Kaplan, Ms. Booth, and Mr. Matusz's public records training seminar attendee designee for 2018 pursuant to R.C. 149.43(E)(1).

SECTION 2. All formal actions of this Council concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council, and all deliberations of this Council or any of its committees that resulted in such formal action were taken in meetings open to the public and/or in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3. This Resolution shall take effect and be in force as of the earliest date permitted by law.

SECTION 4. Effective Date. This Resolution shall take effect on the 13 day of August, 2018.




