**A RESOLUTION AUTHORIZING THE MAYOR TO RENEW THE VILLAGE'S  
EMPLOYEE HEALTH INSURANCE AGREEMENT WITH NFP CORPORATE  
SERVICES THROUGH THE SUMMIT COUNTY HEALTH CONNECTION FOR THE  
2020 CALENDAR YEAR**

WHEREAS, the Village's employee health insurance coverage agreement expires on December 31, 2019; and

WHEREAS, for the past several years, the Village has obtained its employee health insurance at reduced rates through the Summit County Health Connection; and

WHEREAS, the Summit County Health Connection and Village have received a favorable renewal rate quote for 2020; and

WHEREAS, Council desires to authorize the Mayor to enter into an agreement with NFP Corporate Services and the County of Summit for employee health insurance for the 2020 calendar year.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Peninsula, Summit County, Ohio, to wit:

SECTION 1. Council hereby authorizes the Mayor to enter into the attached 2020 Renewal Agreement for employee medical insurance for the 2020 calendar year with NFP Corporate Services and the County of Summit based upon the attached rates and terms.



SECTION 4. Effective Date. This Resolution shall take effect on the 9 day of December, 2019.


