AN ORDINANCE AMENDING THE VILLAGE PARKING VIOLATIONS BUREAU FINE SCHEDULE

WHEREAS, pursuant to Village Ordinance 10-2015, the Village created a Parking Violations Bureau and established a fine schedule for parking violations; and

WHEREAS, the Mayor, Police Chief, and Council desire to amend the parking fine schedule, which has not been updated since 2015.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Peninsula, Summit County, Ohio, to wit:

SECTION 1. Council hereby amends the Village Parking Violations Bureau Fine Schedule that was adopted pursuant to Village Ordinance 10-2015 and is set forth as Exhibit A hereto to the Fine Schedule that is set forth in Exhibit B hereto.

SECTION 2. All formal actions of this Council concerning and relating to the adoption of this Ordinance were taken in an open meeting of this Council, and all deliberations of this Council or any of its committees that resulted in such formal action were taken in meetings open to the public and/or in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3. This Ordinance shall take effect and be in force as of the earliest date permitted by law.

SECTION 4. Effective Date. This Ordinance shall take effect on the 14 day of December, 2020.

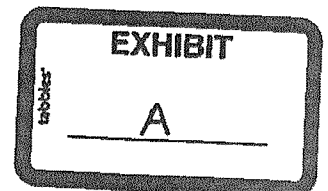
