An Emergency Ordinance Amending Codified Ordinance Chapter 319 Entitled Officer-Operated Traffic Law Enforcement Devices

Mr. Bryan requested a motion to amend the Ordinance to remove the strike-through line through the \$200 penalty amount for school zone violations between 20 and 29 miles over the speed limit. APPOINTMENT


Joint Village and Township Valley Fire Dept. Board Rep. Appointment


